## [Actions around the world to commemorate the International Day of Struggle Against Monoculture Tree Plantations](#)

Hereby we share a number of activities, new materials and media coverages from different countries to commemorate the International Day of Struggle Against Monoculture Tree Plantations 2017.

- Women organizations from several countries from West and Central Africa launched the petition: **“Stop all forms of abuse against women in large-scale monoculture tree plantations”**.

They released it simultaneously urging a stop to the suffering and the violent impacts the expansion of industrial oil palm plantations is creating on women’s lives (violence, sexual abuses, rape, harassment, persecution, destruction of their means of livelihoods). *If you wish to read and endorse the petition in solidarity with these women organizations in Africa, please click [here](#). - In Sierra Leone, nearly 200 women affected by SOCFIN’s industrial oil palm plantations organized a demonstration to urge the national authorities to take action against SOCFIN for grabbing their lands.
